

Table of Violation Types and Penalties Prescribed in Accordance with the Feed Law and Implementing Regulations

Based on Paragraph 4 of Article 32 of the Feed Law promulgated by Royal Decree No. (M / 60) dated 23/9/1435 A.H which states (The Commission shall impose the penalties stipulated in Paragraph 1 of this Article, according to violations types and identification of penalties approved by The Board, penalties will still be effective only after they are approved by the President, and the regulations specify the controls and procedures related to this, and this does not prejudice the Authority's taking the precautionary measures if it deems it necessary).

Definitions:

Large establishments:

Includes manufactories, warehouses and importers of feed.

Medium and Small establishments:

Includes Store Point of Sale.
